Care must be taken when installing this accessory to ensure damage does not occur to the vehicle. The installation of this accessory should follow approved guidelines to ensure a quality installation.


These guidelines can be found in the "Accessory Installation Practices" document.

This document covers such items as:-

- Vehicle Protection (use of covers and blankets, cleaning chemicals, etc.).
- Safety (eye protection, rechecking torque procedure, etc.).
- Vehicle Disassembly/Reassembly (panel removal, part storage, etc.).
- Electrical Component Disassembly/Reassembly (battery disconnection, connector removal, etc.).

### **1. Prepare for the Installation.**

- (a) Open the package and check the part for damage and kit contents.
- (b) Remove any stored items and debris from trunk area.
-  (c) Place vehicle protection over the trunk and rear bumper.

### **2. Install the Cargo Tray.**

- (a) Place the cargo tray in the trunk area with the logo towards the rear of the vehicle and facing up (Fig 2-1).

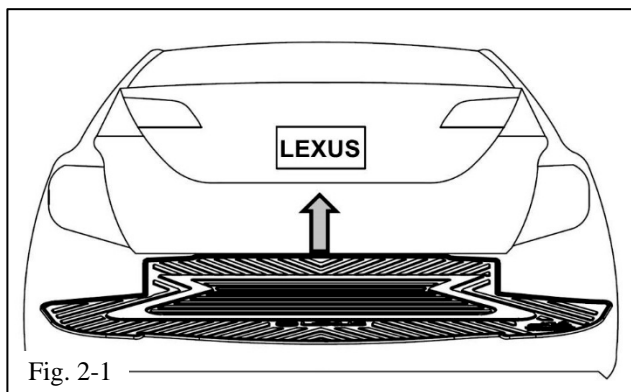
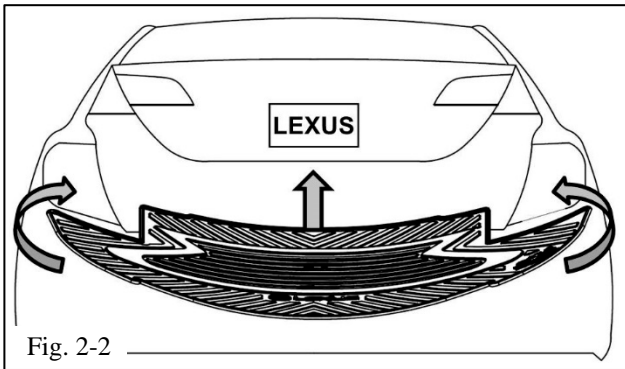

- ⚠ (b) Grasp the tray by the sides and fold up and inward sufficiently to slide it into the rear compartment.
- (c) After installing the tray, ensure all the edges are pushed down against the floor (Fig 2-2).

**3. Complete the Installation.**

- (a) Remove the vehicle protection.
- (b) Close the trunk door.
